About the Art Show

This art show is designed to create a venue that showcases the work of artists and craftsmen/ women living in and around District 2 in Mariposa County and provide the public with an opportunity to see and purchase works of art created by their neighbors and community members.

Artists and craftsmen/women living in or nearby District 2 are encouraged to submit their work. Submitted work should:

- Be representative of artist's current work and created in the past five years.
- Demonstrate high artistic quality and technical skill
- Be presented in a professional manner (framing/matting, proper hanging device/ display stand)
- Be appropriate with respect to subject matter

Eligibility

- All submissions must be original but may borrow images (i.e. collage)
- All artwork must be created by a resident living in and around District 2
- Submitted artwork must be ready to display

Displaying Artwork

Artists shall be responsible for setting up their own display on the day of the show, October 6. Tables and chairs will be available. Artist may arrive at 11am to set up their displays and should plan to be ready by 12:30pm. Display locations at the venue site will be available on a first come, first serve basis. If you are unable to set up your display on the day of the event, please contact the Arts Council or Mimi Jones and we will make alternative arrangements.

FORM B: Authorization/ Agreement

The MARIPOSA COUNTY ARTS COUNCIL, INC., and the ARTIST named above enter into this agreement on the consignment date. The artist agrees to place an accepted item(s) for sale or show in the Mariposa County Arts Council's DISTRICT 2 ART SHOW.

The type of work is described and priced on the received record, a separate document, and retained in the artist's individual file. Prices listed shall be the retail selling prices stated by the artist. All work must be presented appropriately.

The Arts Council will process all sales through the organization point-of-sales system. Having a California State resale number, the Mariposa County Arts Council agrees to collect the necessary state sales tax. Artists will receive the full amount of their sold items, minus 8% for sales tax. A check will be mailed to the artist within three weeks of the event.

The artist is responsible for insuring all artwork submitted.

The Mariposa County Arts Council may use images of the artwork submitted for use in publication and promotional purposes, including printed material, printed advertisements, and online collateral. The artist agrees that he/she will not receive compensation for the use of their artwork imagery by the Mariposa County Arts Council, Inc. for the purposes outlined above. The artist understands in agreeing to the above that the Arts Council is making no guarantees that his/her entry will be used for any of the above purposes and there is no obligation on the Arts Council to do so.

This contract constitutes the whole agreement between the Mariposa County Arts Council, INC. and the artist. No oral or other representations contrary to the terms of this contract may be relied upon and any mediation to this agreement must be done in writing signed by an authorized Mariposa Arts Council, Inc. representative. All disputes hereunder shall be resolved by binding arbitration in accordance with the commercial arbitration rules of the American Arbitration Associations.
